FROM THE CHAIR OF THE BOARD

From one angle, 2016 has been a fallow year for Knox. As I have become comfortable in my own new role as Chair, and as the congregation has adjusted to an ever-growing pile of future unknowns, it's not always easy to see where forward progress has been made.

From another angle, you may have seen the work which has been taking place under the guidance of our loving and energetic teams. From Gratitude-themed Bible studies to drum worship to active sponsorship and support for our Syrian refugee family, the work at Knox in 2016 has been spirited and life-giving. The Board is grateful without end to our all of our volunteers, staff, teams, and team leaders for their gifts of time, leadership, energy, and creativity.

If you'll indulge me for a moment, I'd like to talk about a pivotal moment for the Board this year. In the fall, several Board members (and others!) were privileged to attend a workshop led by Dan Hotchkiss. Many consider Dan to be an authority on church governance. Dan taught us a lot that day, but in particular he held everyone present accountable to the following: "When we don't know what to do, we do what we know.... (but) we're moving into a time where it's harder to be the church. That means we have to get better at it."

So - how does a church thrive, then?

- It defines its purpose aloud a purpose which is relevant to the current social context of its surroundings.
- It earns trust by producing results.
- It gives people a positive experience (Hey how has Knox changed your life?).

Easy, right? Well, fortunately for us, Dan also shared another concept – an epiphany for many of us, who wondered why it's so challenging to move the ball forward: "If a Board is the sum of its teams, and focuses on the day-to-day needs of the church, it is not a Board. If a Board is thinking about what the church should do <u>next</u>, it is a Board."

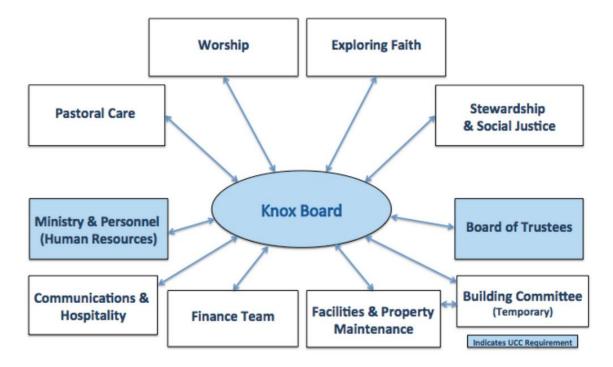
It hasn't been easy to let go of our involvement in the day-to-day at Knox (Insurance? Snow removal? Lost minutes? Old furniture?), but the Board has spent a big part of the last half of 2016 discerning what's next. Yes, we serve and worship God. Yes, we want to comfort the lonely. And how are we doing that right now? To whom is our work relevant? What will we change over the next three years if we are to thrive in the future?

The result of these conversations is a 3-year plan, which will be presented to the congregation at our Annual Congregational Meeting. If supported, we have faith that this plan will help carry Knox into a new future with relevancy, vibrancy, and vitality. And we hope we've kept it simple, too. Whether we are a Congregant, Team member or Staff member, all we need to remember (for now) is our focus for 2017: *Knox, Neighbours, Next*.

EXPLORING FAITH TEAM

Exploring Faith team is an active team with a commitment to build a strong spiritual development culture at Knox. We act to build and strengthen our faith, and create a place to integrate our faith stories within the broader cultural perspective. We want topics that engage us as a group, and build links between us. We hope to build a community where it is safe to express beliefs, hopes, doubts and faith-encounters, in order to encourage and challenge each other in love.

Since its beginning, in September 2015, the team has been exploring various publications to assess their suitability for group study at Knox. We are preparing an annotated list of these publications for individual use, which we hope to have out before Easter.

At the time of the ACM last year the Exploring Faith team was underway with the Tuesday soup-&-study of Jesus 24/7, a 12-week study for the questioning Christian using the New Creed. It helped us understand the New Creed more deeply, and look at basic Christian tenets in its context. This study and format were well-received. Also during the spring, we supported the Stewardship & Social Justice team on the Fossil-free Faith potluck and presentations, an enjoyable and informative multi-faith event.

In the fall, we (ambitiously) prepared a study on Gratefulness, based on the work of David Steindl-Rast, primarily from his book Gratefulness the Heart of Prayer. Knowing the topic is familiar, we delved more deeply into the practice of gratefulness as a way to build our faith, trust and love for God and for each other. During the period of the study, Michelle kept the congregation in the loop via a Minute for Gratefulness in worship services. The soup-&-study format was used, with enthusiasm. We had a positive response, and 3 attendees from outside the congregation.

Exploring Faith has also coordinated with the Worship Committee regarding new Bibles order.

Thanks to Joanne Melville for keeping the Library going.

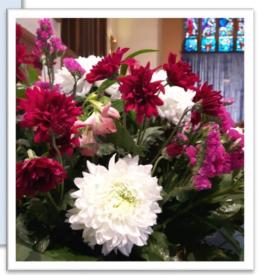

WORSHIP TEAM

As well, we are ably supported by the Knox Choir, Josie Barley, Don Bliss, Ed Williams, Paul O'Neill, Joanne Melville and Joyce Kruger (flower ministry) and the Facilities and Property Team. A myriad of others from the congregation regularly contribute in many meaningful ways to our services. Thank you to each and every one of you!

Liz, Colleen, Madelene and Anne bring inspired planning and execution to our weekly services. Through them we have been treated to prayerful worship, thoughtful meditations, wide-ranging stories, chancel dramas, rich choral, organ and piano music and a fabulous array of musical talent from within and outside our congregation. We are pleased with our commitment to our team's responsibilities within the Music Task Force. This year Madelene and Colleen have arranged for, and in all cases directed or worked closely with, many groups and individuals. We have enjoyed violin, Djembe drumming, our Knox Chimers, trumpet, flute, saxophone, Knox Strings and Winds, vocalists, choral offerings and more!! While some have been guest musicians, we are also most fortunate to have a good depth of musical talent within our own congregation who are willing to give freely of their musical gifts. Thank you!

Team members are responsible for preparing the communion elements, finding communion servers, sourcing scripture readers, ushering and greeting, selecting weekly bulletin covers, decorating the sanctuary for special Sundays throughout the year, approving baptismal requests and much more. Thank you to the Communications and Welcoming Team for training and supplying greeters during the fall season. Once again, we had a bounteous offering of food at our Thanksgiving service, a very meaningful Remembrance Day service and a fun, yet special, Blessing of the Animals service. Maundy Thursday and Good Friday services culminated in our traditional Easter Sunday service of celebration. We hosted a VST student, Kirstin Autio, on Theology Sunday and welcomed her back to the pulpit later in the year. We again supported the important Advent Peace Box initiative including weekly reflections on the Advent themes drawn from the situation in Palestine and Israel. Thank you to the Friendship Group and others who assisted Colleen with decorating the sanctuary for the Advent and Christmas season and to Mary Evans for our First United Can Tree in the Narthex.

The Christmas services presented a special challenge to our staff this year. Because Christmas Eve was on a Saturday, it meant that they had to be present for 3 consecutive services – 2 on Christmas Eve and one on Christmas morning. Each was WONDERFUL in its own way! The early Christmas Eve service saw about 180 people fill our pews and participate with delight as our young folk presented their telling of the Christmas story. Small angels and shepherds joined in eagerly and all returned home with a sparkly star. Many thanks to Anne who wrote and produced this pageant. The 10pm candlelight service was as beautiful and peaceful as ever. Christmas Day found Liz, Colleen, Madelene, Dave and Don gathered with a small group of worshippers enjoying the beauty and joy of the day together. New Year's Day was also a Sunday and Madelene and several others supported Judith Stark for the service. A wondrously, busy season!

The Worship Team participated in 3 baptisms this year. Ryan Pears was baptized in February. We had an interfaith baptism on Pentecost Sunday for Brennan Herzer and Ben Bouguerra was confirmed into membership in the church in June. Supply ministry and assistance this year was provided by Rev. Janice Guthrie, Rev. Sharon Copeman, Rev. Judith Stark, Kirstin Autio (VST student), Heidi Morgan (1st United) and various lay folk. Thank you to the Bradleys for offering a Tuesday evening chapel service.

One of our new initiatives was to replace the sanctuary Bibles. We had a wonderful response to our request for sponsorship of the new NRSV bibles. We are expecting them to arrive soon and look forward to dedicating them at a Sunday service. We also formed a new relationship with the Downtown Eastside Neighbourhood House and invited Heidi Morgan from 1st United to speak at a service. Our team supported the Board's decision to join four westside churches for Summerstream United during the month of July.

CHILDREN & YOUTH MINISTRY

The Children & Youth at Knox range in age from approximately 2-17 years. While many are unable to join us regularly on Sunday mornings, they are still a big part of the Knox Community. They can be found participating in Community Lunch, volunteering for the Thrift Sale, attending Knox events (Fun Night, Welcome BBQ), outreach with our Syrian Family, decorating the Sanctuary for Thanksgiving & Advent, singing in the Choir, ringing Chimes, playing instruments, and participating in special services (Youth Services, Blessing of the Animals, Christmas Eve).

Those that can join us on Sunday mornings help make children's area a lively place! We read books, do puzzles, play with blocks and create all sorts of wonderful artwork. For the past few months, we have been working on creating felt squares that will eventually be sewn together to become a new banner for the children's area. Each square represents one of the themes we have talked about during the services. For example, we have a Rainbow Square (God's Promise), The Earth (Earth Day), Fruits & Vegetables (Thanksgiving), A Star (The Nativity) and many more. We hope to show these to the congregation soon!

Some Sundays, we go into the Vestry for more structured activities and a chance to talk about the themes of that day's service. We are also starting to explore some "Godly Play" activities with our younger children.

Advent was a busy time for us as we had the addition of many grandchildren attending Sunday services with their grandparents. We made decorations for the Christmas tree, sent Mary, Joseph & Pedro off on their Los Posadas journey and helped collect cans of food for First United through our Reverse Advent Calendar. Many of the adults in the congregations joined in the fun as well!

On Christmas Eve, we had 9 of our youth take on roles in the annual pageant. In a change from previous years, the children played all of the parts themselves, as they told the story of The First Christmas. They were joined by a multitude of young angels & shepherds who each went home with a special star to hang on their tree.

In this changing world, outreach is becoming a very important part of our church life. So, in the New Year, we will be turning our focus towards projects designed to help out the children & families at the Downtown Eastside Neighbourhood House... children helping children. We're excited about this new initiative and look forward to sharing our ideas with the congregation in the coming months.

Knox opens its doors to many children in the neighbourhood and has become a safe place for these children to learn and to explore their world. We have Brownies, Scouts, the Preschool children, Acting UP! groups, Little Kickers and more. It may not be a traditional Children's Ministry, but it's a wonderful thing to know that our church is regularly filled with the joyful sounds of children!

OUR PASTORAL CARE TEAM

Our Pastoral Care Team helps our congregational members and adherents celebrate their happy occasions and supports them with the sad events in consultation with Rev. Elizabeth Bowyer. Each of our members has been trained in prayer, listening and responding to peoples' needs. We offer pastoral care by phoning or visiting our church members and adherents at home, in hospital or in care facilities. We practice strict confidentiality.

Our Pastoral Care members include: Rev. Elizabeth Bowyer, Rev. Sharon Copeman, Joan Cass, Joyce Kruger, Helen Overgaard, Sydney MacKenna and Catherine Shen. Several of our congregation do Pastoral Care but are not officially on our team.

We usually meet with our minister, Rev. Liz on the second Tuesday between September and June, when we share our phone calls and visits and our concerns about our congregational members' needs. At each meeting, we respond to her requests and, together, we update the Prayer List. One of our members presents some words of inspiration.

We have a "card ministry" where one of our members sends cards on happy occasions such as "special birthdays, births, anniversaries, marriages or graduation and get-well cards for illness or sympathy cards for bereavement. Please call the office if you know of someone who would appreciate receiving a card for a special occasion.

Our Pastoral Care team is continuing to make a list of CONTACT PEOPLE for the congregation in case of a medical emergency on Knox property. Please call Joyce Kruger if you wish your contact information to be on the list!

Our "Information Package regarding Memorial Services" is still being used when needed by our church members. Our Pastoral Care Team Liaison offers support to those people in that situation by phoning the bereaved family member, meeting the caterer and attending the service and reception.

Three of our Pastoral Care Team: Rev. Sharon Copeman, Sydney MacKenna and Joyce Kruger are still involved with the "Seniors' Working Group" ("the SWG") of the Westside Churches planning committee. There were no special events scheduled this year by the SWG.

We have recently initiated a "Prayer Shawl Ministry". There are seven people willing to knit prayer shawls for those who may appreciate the comfort of receiving one. Several have been given out and more are being made as needed.

On behalf of the Worship Team, we contacted relatives and/or friends of members who have passed away during the preceding year. They are asked to light candles in memory of their loved ones at our annual "All Saints' Day Service". It is a very meaningful service.

We have enjoyed working with Rev. Elizabeth Bowyer this year.

STEWARDSHIP & SOCIAL JUSTICE TEAM

From January through June, 2016, our committee met four times. Our work focused consistently on our involvement with the West Side Churches (WSC) joint refugee sponsorship project, and the on-going Israeli / Palestinian conflict in the Middle East.

In February, we welcomed members of the WSC and Mohamad and Omar to Syria 101, an evening of feasting on catered Syrian food, education, fellowship at Knox.

In May, we hosted a congregational Forum following worship which focused on the strife in Israel / Palestine, with guest resource people from Independent Jewish Voices: Martha Roth, Sid Shniad, Lenna Jones and Jane Power. This Forum was well attended and well received. The UC Unsettling Goods resources were a focus in Sunday worship during Advent, with Peace Sunday most focused on this situation. Our Team has appreciated the ongoing encouragement and involvement of Dave Cass in this part of our work. It is our intention to continue with this educational effort.

Work in the fall continued through individual efforts and electronic consultations, without Team meetings. This included welcoming and working with our young Syrian family upon their arrival, collecting items for a Christmas gift, with a congregational card, and planning for a Knox congregational pot luck dinner celebration in Jan 2017 (attended by 70).

We also were asked to work with staff in developing a Knox Policy and Best Practices initiative for responding to requests for emergency support from community seekers. There is an event planned for staff and volunteers who are most likely to be in positions to receive these requests, to be held Jan 18/17 to be led by Heidi Morgan from First United Church Mission to guide our discussion as we create Policy and discuss "best practices" together. Planning for this event was completed in 2016.

Groups under our umbrella include:

- Community Lunch = \$425 per month for 10 months, totalling \$4250 per year. This sum includes fees for two workers from First United at \$60 each. Funding also comes from Vancouver Foundation at circa \$2000 yearly.
- Sandwich making = 9 times a year at \$40 each, totalling \$360 yearly.
- Coffee served after Sunday Service is usually covered by members' donations.

We appreciate the important work done by each of these groups.

In cooperation with the Finance Team, we helped to plan, prepare and collate materials and promote the 2016 Knox Stewardship campaign.

My thanks to team members: John Carr, Maureen Kinney, Adrienne Burton, Richard Dunsterville, Bill Herzer, and others in the congregation who share in our work.

ENVELOPE REPORT

There are 46 contributors who pledge to the local church, 29 of these also give to Mission and Service. We have 56 contributors who do not pledge but give to the local church and/or Mission and Service. There are 15 people who have chosen to use the Pre-Authorized Remittance System (PAR).

KNOX COMMUNITY LUNCH MINISTRY - Going strong for over a decade!

Knox Community Lunches are held on the second Wednesday of every month, except July and August. Our mandate is to provide a free, nutritious meal and offer a sense of community to those who attend.

It takes many willing workers to successfully orchestrate our lunches.

- Flyers advertising our lunch are distributed at other churches that offer free community lunches. Our sandwich board advertising the lunch is set up on 41st and Balaclava.
- Tables, complete with bright tablecloths, and chairs are set up in the gym. Flower arrangements are added to each table. The gym is transformed into a welcoming dining hall.
- Coffee/tea and goodies are prepared for guests who arrive early and are welcomed into the warm lounge.
 Piano music is played and singing is encouraged.
- A meal consisting of a nutritious, hot entree, salad, bun and dessert is prepared and served to our guests. Juice, coffee and tea is offered.
- Knox folk are encouraged to join the tables to share the meal and enjoy conversations.
- An Advocate is often on site to help any of our guests re housing, completing forms etc.
- Clean-up is handled by two paid workers recommended by First United.
- Healing Touch is offered by qualified practitioners after the meal.
- Funding for this ministry comes from many sources. Donation envelopes are provided in the pews on Communion Sundays. There was a special appeal for funding at Christmas. A donation box is out on lunch days.

The Community Lunch crew is always looking for more happy volunteers. Please consider volunteering for this ministry. "Many hands make light work!" For more information please contact Mary Evans.

THE MEN'S BREAKFAST GROUP

The group continues to meet every three weeks and alternate venues with Dunbar United Church men's group. The numbers of attendees averages 15 - 20, all who cheerfully meet Saturday mornings at 7:30 am, rain or shine. A full breakfast is available, sometimes spearheaded by a plentiful supply of porridge. The group informally discusses a range of subjects, both church and secular. New members are welcome.

HEALING TOUCH

Our group has been very busy this year. The list of people who sign up after Community Lunch shows that interest in achieving a peaceful, restful state is high on people's minds. "Word of mouth" has been our best advertisement as shown by the diversity of people who come and go as well as the regulars. At the Tuesday group, there are typically less after holiday breaks but soon it gets busy as well.

We are fortunate to get assistance from other churches which covers our need with growing number of people being treated. As well the loyal group of fellow practitioners help make this ministry possible. With neighboring Churches holding Healing Pathway courses we have attracted a couple more practitioners who have made Knox their primary place of giving treatments.

Healing Touch uses hands-on techniques that work to restore wholeness of body, mind and spirit by promoting flow of the energy field that surrounds the body. With stresses in life we sometimes block this flow unintentionally. The process attempts to balance this flow which then balances the physical body. Restoring wholeness in this manner opens up and taps an inner reservoir of peace, insight and strength that is available to all. The effectiveness is not dependent on the recipient's conscious belief.

This ministry is under the Pastoral Care Committee and offers sessions to congregation and community on the 1st and 3rd Tuesdays of the month as well as to our friends after Community Lunch on the 2nd Wednesday of the month. We also make hospital and home visits. We consider this ministry a privilege.

COMMUNICATIONS & WELCOMING (HOSPITALITY) TEAM

The Communications Team had a productive year. The various talents of its members have had a positive impact on what we have been able to achieve. Our top priority, which occupied much of the Team's time, was the development of a *Knox Communication Strategy* to focus promotion / marketing both internally and externally. An annual Marketing Calendar was developed for 2016 and has been in use since July. The *Knox Communication Strategy* (including the Marketing Calendar) was circulated to the Congregation for information before the ACM. These documents will be updated as and when appropriate. Susan, Debra and Bruce's expertise were key to the Team reaching these goals. Other initiatives this year include:

- 1. Updating of the Knox Welcome Pamphlets by Sandra Adams for visitors and newcomers. These can be found in the Narthex and Fellowship Entrance Hall
- 2. A project designed to invite and welcome new attendees to Knox in October-December of 2016, based on an expected increase in attendance around Advent and Christmas with three core elements:
 - Promoting Knox using our Communication Strategy principles by advertising in local papers and on the Website and social media
 - Recruitment and training of new volunteers to help with greeting at our services. This was led by Bruce and Sandra
 in collaboration with David Cass.

Evaluation of these activities after Advent with the expectation that there could be more greeters throughout the year

- 3. Proposal to the Board that there be a presentation by each Team and Boards, during Worship
 - Every quarter, each Team will update the Congregation on their activities inviting questions and discussion over coffee. A short summary to appear in News and Notes and on the web the following week
 - The Knox Board and Building Committee will present once a month
- 4. Transferring News and Notes into an electronic format on the web. Printed copies will continue to be available on Sundays. Susan and Josie expect it will be completed by the time of the ACM.
- 5. Exploration of the feasibility of placing photos of Congregation members and their names in the Narthex. This project is in its infancy.
- 6. Improving the physical appearance of the Fellowship Building and others areas in the Sanctuary.

The Fellowship Building is the most utilised part of Knox by visitors, and had not received much attention for years. The environment was not seen as being physically welcoming and needed some work. The areas reviewed, as a high priority, recognising that we would be moving to new space within 3 years, were the Youth Lounge (Room 1), the Entrance Hall and the need for additional storage space.

Furniture was purchased and arrived in the summer. New storage space was created in the Gym and the Room 1 and the much of the Fellowship Building was painted. This was a collaborative project involving the Board, the Building Committee and Facilities and Property Maintenance. Thanks need to go particularly to Larry Tench and Richard Dunsterville, for their hard work in creating additional storage space and painting the rooms, and to Bill Goodsir for managing the interior designer. The Team also recommended to the Board that:

- The Vestry is one of the few private counselling spaces available in Knox and would benefit from being renovated and protected for its counselling and as a meeting space.
- The Chapel become a multipurpose space with moveable chairs instead of pews.

So far funds for these projects have not been identified.

- 7. Implementation of a *Donate* Button on the web
 - The Board supported the installation of a *Donate Button* on the web. Tithe.ly, a software company, have developed software focused on churches. The *Donate* button will be installed within the first 3 months of this year.
 Development of a donate button has been supported by the Finance Team.

The Team will be evaluating their Terms of Reference to determine whether the mix of "Communication" and "Welcoming" is the most effective and efficient way to address these areas at Knox. As Chair, I would like to thank all the members of the Team for their unique contributions and willingness to attend frequent and variable meetings throughout this year.

THE KNOX WEBSITE

37,501 pages of the <u>www.knoxunitedvancouver.org</u> website were viewed by 5,783 **unique** users in the 2016 calendar year. That is an increase of more than 17% over last year. YEAH!

The website keeps us informed with weekly bulletins, news & notes, details on upcoming events and (new this year) an integrated **Calendar** that shows changes the instant they are made.

It helps people connect with each other and the community – like through the **MESSAGE US** feature where **We Answer Back** to inquires about rentals or questions about worship practices; to providing details about joining Rip N Stitch, Healing Touch appointments, or participating in one of the many ministry groups; to confirming where and when a meeting is being held; and a personal favourite - suggested edits for the website.

Over the last 3 years the website has become more than just an "address and phone number listing" – it actually shows pictures and recently, video, of people, the building, and our congregational life - giving all a sense of what we are about. It houses our vision and other doctrinal statements; faithfully offers our Sermons & Introduction to the Scripture Readings; and provides reliable information on what the Board is up too, Building Project Updates, and highlights from our many activities and ministries. It also gives other community organizers and events a way to connect with us. *6 magic words* have become a Knox mantra: For more information check our website.

Knox posts as much information as frequently as we can where thousands millions of people can see it every day – free advertising – yes - but it is also about spreading the gospel. We know that people are lost and hurting in the world and many have questions about God, The Bible, Jesus and the church. People want to read and research spiritual issues in the privacy and comfort of their own time and space. The cool part is – that they **share** it with their friends, so many more people are now using our *resources* than the number of people specifically associated with Knox.

In 2016, Knox has been intentional about *growing the resources* offered on the website and rewarded by the awesome reach we witness when something resonates with our visitors – like on July 27th – our busiest day on the website - when 500 people paid us a visit. Other days that hit around the 500 visitors mark – October 5, June 23, August 7, December 6, April 21 and December 30 – just type the date into the *Search Bar* on the website to see what features got us those terrific traffic stats.

One of the greatest benefits of the Knox website is that it constantly challenges us to think about **what is important about our church**. Many thanks to all of you who contribute to the website – and there are more of you than ever - YOU make the website a **Web Ministry**. It is indeed my privilege to serve as your webminder.

A REPORT FROM YOUR MINISTRY & PERSONNEL TEAM

Last year our report identified how we operate in support of our staff and act as a resource for the congregation in staff related matters. This is important information for all of us and is worthy of repetition as you will see below.

During the year we meet with each of our staff members to review their job descriptions and to share their accomplishments and plans for the future. It is also a time to listen to their concerns or suggestions that will make our operating procedures more effective.

The M&P team works closely with the Board to assist with the interviewing and hiring of new or replacement staff. We also make recommendations to the Board based on our conversations with staff members. These recommendations can range from working hours and conditions to compensation and vacation requirements.

In addition to our annual staff meetings we are always open to spend time with our staff when special circumstances arise. **All our conversations are on a confidential basis.**

If you have concerns or suggestions regarding staff, we ask that you share them directly with the M&P team who will follow up on your behalf with the appropriate staff members.

We also encourage you to share your support and appreciation directly with our hard working and valuable staff members.... we all like to be recognized for our efforts!

We welcomed Anne Earthy to our group in 2016. This year Knox profited from an M&P Workshop, led by Marc Coulombe, Conference Minister. In addition to our own M&P team who attended the workshop as a valuable refresher course, many members of our other Knox committees were also present to better understand our personnel responsibilities. This experience was a benefit to all.

FACILITIES AND PROPERTY MAINTENANCE (F&PM) TEAM

This committee is responsible for the maintenance of the Knox property. The members are: Ed Williams, Richard Dunsterville, Don Bliss, Larry Tench, Wendy Trant and Berkeley Scott. We have been successful in holding three meetings this year and this has helped us in identifying needed work and possible future work.

Completed Projects in 2016:

- The building committee purchased new furniture for the new building early in 2016 and these were used to replace much of the existing furniture in the Fellowship Center and the vestry.
- A new storage area was built in the gymnasium to clean out the material that was cluttering the gym floor. This new storage area has become a necessity and was very useful for our spring sale which allowed us not to rent an outside storage bin. It also has been used to store furniture for both Syrian and Tibetan refugees. There were six volunteers building this project.
- The youth lounge (room 1) was painted and the majority of the interior doors were also painted to improve the appearance of the Fellowship Center. The gym doors were also painted.
- A baby-changing table was purchased and installed in the handicapped washroom off the Narthex.
- LED lights were purchased to allow replacement in the church. Some have already been replaced. To replace the sanctuary lighting will require the pews be unbolted from the floor and moved, thus allowing the electric man-lift access to the high lighting fixtures. We plan to do this in 2017.
- We have significant damage to the front lawn due to crows and racoons digging for chafer larvae. We had treated the lawn twice with nematodes but it didn't eliminate the larvae. Much of the damaged lawn was removed and reseeded with clover and fescue grass. We will wait and see if the results are alright.
- We held two Gumboot Parties (spring and fall) to clean up and improve the inside and outside of the buildings. The fall one was not as successful as hoped since we only had about 6 volunteers but we did have 14 in the spring.
- There was flooding in the sewer line from the church due to both a plastic bag and tree rootlets. This was cleaned by the COV and the Rooter-Rooter Co.
- A new Router was purchased to improve the WIFI capabilities in the Fellowship center.
- The emergency first aid kits in the two buildings were cleaned and re-filled with the appropriate supplies.
- The sound system in the sanctuary was up-graded. This included the hearing -impaired headphone system.

2017 Projects for consideration: carry-over from 2016

- To meet new regulations for our buildings we are investigating the need for lighted exit signs (we have received free units) and new panic hardware for the two main entrances to the church (these will allow these doors to be locked but still provide emergency exiting). Investigate whether proposed small windows in the main doors will meet the heritage rules for the church. F&PM will follow-up on purchasing fin seals or other type to minimize air loss through the inner doors when outer doors are open. The small window and renovation should be handled by the Building committee.
- A lawn sprinkler system would improve the facility grass and gardens, and would also require much less time to maintain. This should be coordinated with the new building plans for its new gardens.
- Overall review of the yard plantings to make the exterior gardens more appealing and appropriate for the church setting.
- The plastic window covering on the Chapel windows were removed for painting. The Chapel windows were renovated to allow new plastic (still to be purchased) to be installed but still allow the windows to be opened.
- The plastic on the east side of the church windows were also removed for painting, but presently have not been re-installed. The middle window plastic could be re-installed since it is in good condition. The plastic over the other three large windows are all cloudy in appearance and will not be re-installed. The question is should we replace these cloudy panels with new, clear plastic?

- The Knox Church community would like to see a more inviting presentation of both the exterior and interior of both buildings. Changes or additions will need to be identified that will reach this target.
- The concrete floor in the sanctuary will probably be sealed this year to prevent coffee staining, thus the sanctuary could become more useful for functions where coffee is served.
- Investigate how to improve the WIFI service throughout the church and fellowship center.
- This will be the year we start the building of the new fellowship center, so we expect many unexpected problems and challenges to occur.

I am especially thankful to some of the committee members who seem to always look for potential problems in the facility and the grounds. This makes our meetings much more productive. A special thank you must be extended to Paul O'Neil who is always committed to doing that extra effort for the benefit of the church and those whom he works with. Thank you, Paul!!

- established an Investment Committee and developed an Investment Policy for the proceeds from HON Towers Kerrisdale Ltd. and submitted to the Knox Board for approval.
- suggested the need for closer cooperation among the Trustees, Finance, Building Committee and Board. This resulted in a very productive joint meeting of these Teams, led by the Board Chair, on November 9th.
- are working closely with the Finance Team to create an ongoing Cash Flow Analysis to ensure appropriate funds are made available for Knox's operating expenses.
- have engaged Robyn Brasell to undertake its accounting needs for the Trustees' Accounts.
- in keeping with its responsibilities for Knox's insurance needs, met with Dave Mills of HUB Insurance to ensure there is adequate coverage both now and as the Project unfolds.

Many thanks to Joanne Melville as she leaves the Board of Trustees after many years of faithful service. Thank you, Joanne.

FINANCE TEAM REPORT

During 2016 the Finance team worked closely with the Board and our appointed accountant, Robyn Brasell to improve the clarity of our financial reporting. Recognizing that as we approach 2017 we will experience an increasingly complex cash flow with the advent of earnings from the Project capital investment and the potential capital gains from that source in future years. To accommodate a reliable system to track these finances it was agreed by all concerned that we would:

- 1. Retain monthly statements for Knox operating income and expenditure as a responsibility of the Finance team.
- 2. Implement a separate monthly statement for The Building Committee to ensure efficient management of all expenditures that will be incurred for completion of the Building Project.
- 3. Initiate a similar monthly statement for Knox Trustees as they oversee funds held and invested by that group.

While Finance will be responsible to the Board for the Operating statements they will also receive copies of the Building Committee and Trustees statements to ensure an overall understanding of the Knox financial situation.

Along with these important initiatives Finance is pleased to report that, with your generous pledged donations, and other sources of important income, we completed 2016 with a reduced deficit of (\$109,000) against a projection of (\$138,000). This resulted mainly from delayed hiring plans and the careful expenditure of all committees.

As we enter this new year you will see in the proposed budget for 2017 the first inclusion of projected interest payments from the investment of capital received from the developer Hon Towers of Kerrisdale. A very positive move as we plan for the continuation and expansion of our ministries in the years ahead.

Finally, you have faithfully responded to this year's Stewardship Campaign which has achieved our targeted objective. Without this essential base of income our plans and future would be challenged.

The future is never totally predictable but with the beginning of our building project now in sight, and your continuing financial support, we can plan for a new way forward that will allow all of us to achieve our Mission and discover what it means to be a faithful Church in a changing world. With the message and life of Jesus as our compass, all things are possible!

BUILDING COMMITTEE

In early Summer 2016 we were advised that the City had notified the developer that the Planning Department was satisfied that all outstanding questions with regard to the Development permit had been answered. This comforting statement was accompanied with the advice that the application and the Developer's responses would, as a last check, be circulated to all City Departments; Fire, Heritage, Health, Legal, etc. We were also advised that this exercise would take approximately three months.

In September, we were advised that the Legal Department had indeed identified some lingering requirements and these requirements related to unfinished and unsigned agreements relating to the Preschool, Heritage, the transfer documents and bonds to guarantee Developer performance. These documents, and probably a few more, were in the Legal Department unfinished business file. Since that time the City Lawyers and the Developer's Lawyers have been working on these issues and we are led to believe that the process is nearing completion. When these matters are finally resolved, we can move to the preparation of working drawings.

We can take some comfort in the fact that several months ago, the Developer agreed to compensate us financially for income lost as a result of ongoing delays. We do, as a result, have a monthly income which we believe compensates us appropriately.

The question remains, and is becoming increasingly important, when will we see some palpable progress? We can, because of the performance of the City, only guess. Best guess is that in mid year we may expect action on the site.

The full day itinerary started off with Knox hospitality followed by Worship themed around Reconciliation and the UCC Apology. Gifts were presented to graduating clergy and music filled our sanctuary. Joys and Concerns of the Presbytery, energetic chatter and a fast paced business meeting which included elections of the executive for the upcoming term took place in the Fellowship Hall.

A beautifully laid out catered lunch with the retirees as special guests, was served in the gym as participants gleefully networked. Presentations included the God/god Survey by Richard Bott who, that very morning, had been featured in the Vancouver Sun

Through a process of mutual invitation (Eric Law) the afternoon session focused on table groups passing a speaking stone to talk about the question: "How does what I believe about God, transform my life?" Prayers, discernment, feedback and Communion offered by the incoming and outgoing executive chairs concluded the day.

Tsawwassen United Church hosted the next full court meeting in October 2016 with a similar format! We began with worship and engaged in triad exercises of Prayer on Gratefulness .**The Business Meeting** was very informative.

- Marc Coulombe presented on Pastoral Relations and joined Knox later in the Fall to run a M& P Seminar.
- Richard Bott, Deb Bowen and Blake Field all reported on the Ryerson/Dunbar Amalgamation process.
 The big take-away was "Don't wait until you need to down-size, move, do it now while you have
 options" This was a 6 year process for these churches. Dunbar is giving up their building and for at least
 the first 3 months, Ryerson is giving up their name. The church will be known as Dunbar Ryerson United
 Church with congregations coming together as of January 2017.
- Judith Stark gave a report on all the **Properties** sold or being sold in the Presbytery. Knox was the only property that did not have "social housing, work-force housing or affordable housing" impositions for a set number of units. It was also the only property with interest payments that were more significant than the buyout revenue stream well done Building Project Managers!
- Dan Kirkegaard presented **several internal matters** including the Full Court Meeting Survey Summary, and placing our student ministers in charges before ordination or commissioning, and the stewardship toolkit.

In December Debra lead a Workshop for the Knox Board (and others) around the Remits as proposed at the 42nd General Council meeting.

There are 3 remits being voted on by February 2017. They are voted on by Presbyteries only and are about our understanding of ministry. The rationale is for ONE, simpler design, Order of Ministry. These remits deal with Ministry Partners, Candidacy Pathways and a New Model of Membership. Vancouver South Presbytery will cast their votes for remits, 5, 7 & 8 at a full court meeting to be held at Steveston United Church on January 21, 2017.

The proposed changes in another classification of Remits to be voted upon starting in June 2017, will directly impact congregations.

The Knox Board has scheduled a FORUM on MARCH 26, 2017 after worship to begin our conversations around the Pastoral Charge (congregational) Remits.

Here is a summary of the Congregational Remits we will be discussing:

- Remit 1, "The Three Council Model," redefines congregations as "communities of faith" and outlines many aspects of how the communities will function, including membership, authority and responsibility, governance, spiritual life, and ministry and other leadership.
- Remit 2, "Elimination of Transfer and Settlement," eliminates the option currently open to congregations to request a minister through the transfer and settlement process, and means each community of faith will be responsible for finding their own ministers through needs assessments and search committees.
- Remit 3, "The Office of Vocation," affects the standards of accreditation, oversight, and discipline of the ministers serving our congregations.
- Remit 4, "Funding the New Model," directly impacts how our donations to the United Church Mission and Service fund will be spent and how resources will be shared across the United Church.
- Remit 6, "One Order of Ministry," impacts the education and training ministers in our pulpits will receive.

As Presbytery Rep I represent the Knox congregation to the Vancouver South Presbytery and VSP to Knox – your thoughts, concerns and comments are important to me, to Knox, to VSP and to the UCC. Let's **TALK** – you can leave a message through the website **MESSAGE US** button.

We are pleased to report that the combined 43rd Kerrisdale-Centennial (Knox) / 21st St.

Mary's Wolf Cub Pack has resumed its program activities for the 2016-17 Scouting season. We had a great start in September, with a completely new leadership team. Former Beaver Leader Christian Malcolm stepped up as Akela and Contact Scouter for the Cub Pack. He was joined by Allan Askew, Tarek Ward and Xin Wang, who all have children in the Pack. 11. New Teams:

<u>Faith Exploration</u>: Michelle McMaster, Chair – The team welcomes suggestions and is excited to present upcoming opportunities to explore faith. This team began its work in 2015 by organizing a Fossil Free Faith Forum, and has been running a Bible Study course (Jesus 24/7) since the start of 2016.

Stewardship & Social Justice: Sharon Copeman, Chair – The team reports that they have only just begun their work. The largest ongoing project is the sponsorship of a Syrian Refugee family. An application has been made for their extended family to join them in Canada. Watch for upcoming opportunities to raise funds and lend your support for many global and local concerns.

<u>Communications & Welcoming</u>: Susan McAlpine, Team member – Susan reported that the team has met three times since the fall. Current project includes a décor facelift for the common areas of the Fellowship Building in particular, and the development of a Knox Communications Strategy.

- 12. <u>Board Report</u>: Chair, Margaret Pendray, acknowledged how much work had happened at Knox this year. She provided an overview of 2015 and the many projects, events supported, and funds raised by the congregation. Margaret then went on to provide an overview of the Board's priorities for 2016.
- 13. Trustees Report: Doug Graham thanked Leo King and Bill Goodsir for their work and dedication. Doug welcomed Lori Marzin and Joanne Melville to the team. Doug provided an overview of the Trustees' Statement of Cash Receipts and Disbursements. The Investment Committee, a sub-committee of the Board of Trustees, is expecting to be ready in time to make decisions on how the \$4 million of capital from the property sale will be invested. The Trustees report on page 22 of the 2015 Annual Congregational Report should be omitted.
- 14. <u>Building Committee Report:</u> Bill Goodsir reported that the City of Vancouver has begun to investigate traffic flow patterns during the construction project. A meeting will be held in the near future. To date there is no date yet for project commencement. Bill provided an overview of the contractual terms of the property sale, along with how the resulting cash will flow and be managed. He suggested that there will likely be surplus funds available from the \$600,000 available for the project, and the congregation may wish to explore upgrades to the facilities: eg. AV system, Sound system, shared space décor facelifts.
- 15. Larry Tench advised that there will be a gumboot cleanup in May. Please watch for a date to be announced soon.
- 16. Motion to accept the 2015 Annual Report by Phil King; seconded by Michelle McMaster. Motion carried unanimously.
- 17. 2016 Finance Report & Budget: Alan MacKenna thanked the families of Catherine Dunham and Reg Wilson for bequests made to Knox and to the UCC Mission & Service Fund this year. Alan reviewed the Operating Revenue section of the budget, which reflected last year's budget, actuals, and the proposed 2016 budget. Alan reviewed the Operating deficit, which reflects sufficient funds to operate for roughly another 2.5 years -- independent of the interest income from the property development. Alan called for a motion for Knox United Church to accept the 2016 Budget as presented, which was developed by the Finance Team and the Knox Board; seconded by Doug Graham. Motion carried unanimously.
- 18. Nominations Report: Berkeley Scott thanked the members of the team for their service this year. He recognized those who have resigned (stepped down) from teams this year, many of whom have moved to other teams, and identified new members to various teams. Berkeley Scott moved that the nominations slate be accepted as presented; seconded by Mary Graham. Motion carried unanimously. The Chair called for any additional nominations from the floor. There were none. Richard Dunsterville drew attention to the fact that the Treasurer and Presbytery Rep positions remain vacant. The Board will continue to work at addressing this issue.
- 19. Election of ACM and Secretary for 2016: Margaret Pendray proposed the option of electing a Chair and Secretary for the balance of the year, should any additional Congregational Meetings be called. These individuals would serve until the ACM in 2017. Traditionally at Knox, the Chair and Secretary have been the Chair and Secretary of the Board, but they do not have to be. Richard Earthy moved that the Chair of the Board and the Secretary of the Board be the Chair and Secretary for the Congregational meetings in 2016; seconded by Bob Copeman. Motion carried unanimously.
