FAQ:

What do you mean by <u>"the arts"?</u>

 The term, "the arts", refers to every creative activity and expression, including <u>literature</u> (drama, poetry, prose, etc.), <u>performing arts</u> (dance, music, theatre, etc.), <u>visual arts</u> (architecture, ceramics, drawing, painting, photography, filmography, crafts, sewing, sculpting, etc.), and <u>culinary arts:</u> (the art of preparing and serving good food, the study of relationship between food and culture)

Why <u>"the arts"?</u>

- The medium of the arts and arts-making is the most effective way to welcome the people of all backgrounds (race, culture, color, nationality, language, lifestyle, orientation, etc.) in one place to build a sense of well-being for all.
- The doing of the arts and arts-making melts hearts, opens minds and brings neighbors of diverse backgrounds together to build a welcoming neighbourhood.
- The ministry of the arts and arts-making is the most authentic and inclusive way for the church to engage its surrounding neighbourhoods. (In the past, the church was the best patron of the local arts)
- Knox has identified the arts as the main strength and key ministry to grow further.
- By engaging our neighbours through the arts, the Knox desires to champion the neighbourhood arts and arts-making.
- Our new building can be a centre for the neighbourhood arts and arts-making.

Why "Loneliness"?

- The issue of Social Isolation and the Loneliness has been identified as one of top social challenges facing the people living in the city of Vancouver, especially those neighbours, mostly seniors, living close to the Knox United Church.
- This issue has been identified as the most challenging social issue facing the people of Knox.
- By becoming a radically inclusive church, the Knox U.C. can position itself as a sanctuary for the isolated, marginalized, and lonely ones living near the church to belong and feel a sense of home.
- Knox can partner with other neighborhood groups and individuals in working toward building a neighbourhood without loneliness.

What is Mission and Vision?

- A Mission Statement describes why the organization exists.
- A good mission statement is clear, concise, and useful.
- A <u>Vision</u> Statement describes <u>where</u> the organization wants to be in the future.
- A motivating vision statement is clear, concise, inspirational and memorable.

What is Church's Mission and Vision?

Church's Mission is given by Jesus.

<u>Church's Vision</u> is <u>unique</u> to its local church (<u>niche</u>), in that, it reflects the yearning of the people in its surrounding neighborhoods (<u>contextual</u>) and seeks to bring about a sense of well-being to its neighbors (<u>missional</u>).

Knox Ministry Team Goals (2019 - 2021)

Worship Team:

- 1. To grow our (Sunday worship attenders) numbers including a goal of increasing our younger attendees.
- 2. To offer alternative worship services different styles, aiming for radical hospitality. May be included in Sunday morning worship and/or offered at different times and locations.
- 3. By 2021 various forms of the arts will be fully integrated into our worship services and appreciated as such.

Social Justice Team:

- 1. We desire to help the Knox UC to lift up the justice of God by advocating and working on lifting up the causes of those who are marginalized in our society by continuing to work on our existing Social Justice activities: Israel/Palestine Relation, Refugee Advocate, Monthly Community Lunches.
- 2. To advance Knox's new vision direction, to build a neighborhood without loneliness, we desire Knox UC to be a radically inclusive and hospitable place for all to belong by becoming an Affirming Church by the end of 2021: by the end of 2019, we will initiate the process of "Affirming Church".
- 3. We have been called to care for God's creation. As a part of caring for our earth, we desire to live out a good stewardship practice at Knox by eliminating (minimize) a single usage of plastics in our church and families and promote this stewardship practice in our neighborhoods.

Pastoral Care Team:

- 1. Creating Pastoral Care Handbook for P.C. team members to provide more effective P.C. ministry
- 2. To provide pastoral care ministry presence on Sundays by designating a team of pastoral care ministers on Sundays before, during and after worship.
- 3. To reach out to our neighbors to provide pastoral/spiritual care for those who are isolated and lonely, and to those who are seeking and in need of pastoral/spiritual care.
- 4. To network with local churches in providing better pastoral care for the wider community.

Exploring Faith Team:

Our goal is to help our congregation become more like Jesus.

- 1. We aim to become a body of people rooted in our Christian faith in Scripture, in the person of Jesus, and in our traditions to facilitate a transforming life.
- 2. Like Jesus, we aim to become people of radical hospitality, actively opening our understanding, our hearts and our lives to our neighbors. We aim to love as God loves us, God being our helper.
- 3. We aim to explore the theology and knowledge of beauty, of the arts, as means of connection with God and with our neighbors.
- 4. Christian Discipleship Formation: Help people to anchor their faith in the Christian scripture, tradition and practices to become faithful followers/disciples of Jesus Christ (Informational/Transformational)

Welcoming /Communication Team:

- 1. Have more signage in place outside and inside the church and fellowship center
- 2. Hold a series of sessions on brainstorming/workshops on welcoming/follow up what works in other places? What are we doing today that makes people feel welcome?
- 3. Hold a series of Country-themed gatherings where we share food from the country and people who have been there share their stories.
- 4. Have the greeter Team and all Knox attendees know and use the methods we will have in place to encourage continuing attendance by all----both Knox "regulars" and guests (we like the term guests)
- 5. Having Knox be a welcoming center for the community: Have 1-2 annual arts events in our space that are anchors in the community and have media coverage of these arts events to increase our outreach, so we connect with the lonely. Tie in a launch event to our new fellowship center

Message from the Minister

"--- you are citizens with the saints and also members of the household of God, built upon the foundation of the apostles and prophets, with Christ Jesus himself as the cornerstone. In him the whole structure is joined together and grows into a holy temple in the Lord."

Ephesians 2:19-22 (NRSV)

The cornerstone (akrongoniaios in Greek), or foundation stone or setting stone, in Paul's time is the first stone set in the construction of a masonry foundation - important since all other stones will be aligned and set in reference to this stone, thus determining the position of the entire structure. This is the significance of Jesus to the foundation of the church. Apostle Paul reminds the church that Christ is the first and foremost element of the undergirding structure upon which everything else is aligned.

The year 2018 at Knox was a year of setting and aligning all its ministry in reference to our cornerstone, Jesus Christ. At least, that's what I endeavored to do when I looked back, to encourage and nudge Knox to move in closer proximity and relationship with the person and teachings of Jesus Christ. Thus, my focus on Sunday morning services was mainly based on the gospel lectionary texts throughout the year. In deep gratitude and humility, I thank you, Knox family, for your spirit of willingness and trust in embracing and encouraging one another, and me along this challenging adventure.

I came to Knox as a temporary minister in January 2018. My ministry focus as a temporary minister was to bring a sense of grounding to the congregation and help guide Knox to advance toward its threeyear plan, Knox-Neighbours-Next. This, while Knox searched to call a permanent minister. I believed a dynamic and transformative worship experience and on-going pastoral care delivery would ground the congregation, while the effective leadership team and system, including board and committee work and staff relationship, would bring fruitful outcome to the plan.

So, in Worship areas, with the help of our worship team and the talented worship craft team, I focused on implementing and experimenting with sensory and participatory elements in our Sunday worship services, especially during Lenten Season. The goal was to create worship experiences that would be transformational for the worshippers. We have continued to implement diverse ways; sensory, participatory and the arts, to enhance people's worship experience throughout the year, and this will continue to evolve.

I've had the pleasure of visiting and knowing many Knox family members, beginning with a pastoral visit with a member in hospital on the first week of my ministry at Knox, and subsequent pastoral calls and visitations, and casual visits in the next few months. In the past, for the purpose of getting to know the congregation, the pastors had routine annual pastoral visitations to every church member on a regular basis, which I did in my previous pastoral charge. I am not sure at this point, whether this would be an effective or feasible method when we consider our current social/church context. But it is something worthwhile to explore in the future. I have given pastoral care training to our pastoral care ministry team. The team has been faithful and effective. Rev. Sharon Copeman has been a great source of help in assisting many duties relating to our pastoral care tasks, including weddings, funerals, hospital visits, and as an emergency pastoral care minister while I was away.

Initially, in the areas of working with the church board, committees and staff, I have had several person-to-person meetings - with Board chair, M&P chair, Building Project chair, Pastoral Care chair and Rev. Sharon Copeman; each worship craft team member, and church website administrator, for connection and help in updating me on the ministry and history of Knox. I have continued to meet with them regularly for further discernment and discussion for Knox future. In the Knox Board matter, I have met regularly with the chair for preparatory meetings prior to each board meeting to strategize how to most effectively use our time together as a board (oversight, visioning, and delegating), while initiating bi-monthly board breakfast gatherings (Soulmatter) for a deepening relationship.

For staff matters, at the beginning of last year, I have initiated regular monthly staff gatherings (choir director, organist, children's minister, church officer, church maintenance person, church administrator, and myself) for personal/performance check in, team building, church operational matters, and devotion (every first Wednesday of the month for one hour at 11 am.). These meetings have been very fruitful for the effectiveness of church work and for the clarity of staff communication.

Since I have been called and shifted from a temporary to a permanent minister, in April, I needed to look at Knox ministry from a long range and broader perspective. I began to discern and ask how Knox can be a thriving church in the future – not just to survive but to thrive. In other words, the main question was how Knox can be an effective missional church to carry out God's Mission faithfully in the world. Knox has had a fruitful ministry in the past and there are ministry programs that are still vital and relevant to, not only the Knox family, but to the wider community. And yet, it has been my observation, that Knox did not (or were not ready to) fully grasp a clear ministry direction for the future. Yes, the building project is one clear indication, but we were not clear on how this new project could enhance Knox and Knox ministry, mission, and benefit our neighbours as well. Yes, Knox wanted to shift from a maintenance church to be a missional church, but there was little conversation on what it meant to be missional. Knox had mission/vision statements and yet, they needed to be refined in our own context to be effective and faithful.

For any organization (including church) to be effective and thriving, there has to be clarity in its direction – in other words, a clear, convicting and motivating vision is critical. Our mission as a Christian church is given to us by Jesus Christ, in the great commandment "to love God and love our neighbours". Our mission is to live out that commandment. But what sets each local church apart is its vision – how we are to carry and live it out in our own local context. That is why the church vision has to be both missional (outside of church building into its neighbourhoods) and contextual (incarnational) to its locality. So, we began to do the visioning process in the season of Easter. I preached on the Book of Acts, to biblically ground us in our journey as we examined and were guided by the early Christian church's example.

After a few months of conversations (on church board level, committees, and a leadership retreat), we drafted two clear directions for Knox to carry out our mission to love God and love our neighbours: loneliness and the arts. At the end of June, at a congregational meeting, we, as a congregation, approved our new mission and vision statements (along with vision tag-line). Thus, we have the following:

Mission: We exist to love God and our neighbours. Vision: We aspire to engage our neighbours with the arts, building a community without loneliness.

Vision Tag-Line: engaging neighbours with the arts

It will take a while for us to fully own and be passionate about our new vision. Any thing new takes time to grow. And it requires commitment and taking certain risks to mature. This means, how we organize and do church work must be revisited and refined for the vision to grow. And this requires much courage, faith and love.

During summer and fall, I have focused much of my energy in working with Knox church Board and committees in setting up ministry team goals and objectives for the next 3 years (at least) in light of our new mission and vision. This work has progressed for several months and toward the end of fall, all programing committees (Worship, Exploring Faith, Pastoral Care, Welcoming/Communication, Social Justice) were able to prioritize their goals and make recommendation to the church board for approval, which the church board did. In November, we had a leadership retreat and invited Marc Coulombe, a Regional Minister, to lead us in looking at what lies ahead in terms of reimagining and restructuring our future, including our staffing, financing and programming in light of our new vision. In the last 2 months of 2018, I have worked on drafting and prioritizing ministry programs for the year 2019 (and beyond) based on the goals of each committee and in light of our new mission and vision (*please review the attached mission, vision, FAQ, committee goals, and 2019 Spring key programs and activities pages for your information and review.*)

Meanwhile, I have participated in Summer Spirit worship services (preaching and presiding twice). It is my observation that while the Summer Spirit worship services were enjoyable and brought a sense of unity among local United churches, I think we need to discern how we can begin to work closely together considering our new structural shift within our denomination, from 4 to 3 court system, in the United Church of Canada. This requires much discernment and conversation within us and with our neighbouring United churches. I have spoken this with the church board in the past several months. But this needs to be one of our priorities as a church in the coming months and next year.

The Loneliness Forum in October was a huge success, in that, we have established community wide network and partnership (community groups and individuals) in working together toward "building a community without loneliness". Based on this foundational gathering this year, we will host and work in partnership with various community organizations and leaders in Conversation Café (Loneliness Café), and already certain projects are on the go. One other exciting program that I am very delighted to see happen this year, which emerged out of our church vision focus, is our Knox 2019 Lenten Lecture Series: on Loneliness, where Knox is able to partner with Vancouver School of Theology in hosting 5 lectures during the Lenten season. The preparation for this event took several months beginning in the fall of 2018.

There are many other areas of church ministry last year which I did not mention here which people can review through my minister's monthly church board reports. Over all, it has been a very busy year for me. But it has been a very fruitful and exciting year as well. To end my report, I like to share briefly what I have reported to our church board at the beginning of January, 2019. We have a new mission and vision for Knox. And, the ministry programs are new and evolving. This requires us to focus on a fresher ministry direction, mindset and role. (For full report, please review Knox board January minutes available at the office):

"--- since the programs are new and missional (outward orientation and non-traditional church programs) in nature, they will require outside of box thinking and action in the areas of finance and staff restructure, as well as how we need to adjust how we view church and church work. **Knox has entered into the year of exploration & experimentation.**

Therefore, I like to think of our role as Knox Board and board members <u>as Vision Keeper</u>: The board as a vision keeper has following key areas of task - by <u>Owning the Vision</u>: make the vision personal; <u>Communicating the Vision</u>: tell, retell, reinforce, and tell again --- have a personal dialogue yourself to ingrain the vision into your heart before you can communicate to others ("why do you go to church/Knox? – to love God and love our neighbors; how are you going to do it?: at Knox, we try to live out our mission through our vision; why arts / why loneliness? – well, let me tell you why --- FAQ.); <u>Championing the Vision</u>: Be a cheerleader, follower, promoter, and champion of the vision, goals, and the programs by participating and supporting anyway you can; <u>Support the Vision</u>: through church programs & schedule, be creative in how to provide resources (finance, staff) – think, suggest and act outside of box; and <u>Overseeing the vision (Vision Keeper)</u>: keeping the ministry teams, staff and each other accountable to the vision and their goals. Main question to ask: <u>how did this program advance our vision?</u> (Why, why not?) And ask, what/how can we do better?"

Well --- that's it for my report for now. Sorry for the long read, folks! I didn't intend it to be this long --- but --- I did. God has been more than good to us in the year 2018 – and will continue to challenge and bless us in 2019. And Knox, you have been faithful and patient with one another, and very good to me and my wife Sue. I am honored to be your minister. I am very excited and challenged by our vision to engage our neighbors with the arts (and) build a community without loneliness. This is an awesome adventure to be on. Let's keep the vision alive – let's keep each other in love, as we love God and love our neighbours.

Think of all the projects and events we've held in a mere 365 days! A leadership retreat, a financial review engagement, congregational meetings, a refined Vision & Mission statement, Summer Spirit participation, our annual Thrift Sale, a Covenanting service, the Loneliness Forum – and these are just to name a few. The comprehensive list goes on and on, as you will read in our various team reports. And while the construction project hovers on the horizon, we know that the vision we are working towards, connecting neighbours through the arts and building a community without loneliness, will see our hearts and minds focused on the worthy work that God calls us to do.

Our dedicated teams and staff have continued their important work throughout all the changes we experienced in 2018. Each of us have had a role in serving and supporting our community: hot meals, creative worship, prayer, healing, diligent care of our property, thorough financial management, faith development, life events, and urging us into action on social justice matters. 2019 holds great promise as we anticipate concerts, art installations, refugee support work, conversation cafes on loneliness and isolation, monthly pot luck lunches, guests in worship, and continued efforts to refine our programs to closely align to our vision statement.

And so we welcome 2019 with great hope for the potential that awaits us, and with thanks for all of the good gifts around us.

Now in our fifth year, the Knox website is an important extension of the Knox story. It helps strengthen Knox United Vancouver visibility and provides 'always on' communication across many audiences. Knox has moved from '*content*' focused on information to '*stories*'

that provide a way for **people to connect**. An example of this is the way we used storytelling with images of ART to introduce each of the Advent segments on the web. Rather than stodgy reporting, we incorporate video, culture driven images and tennis-shoe language to help visitors learn about who we are. We appeal to community rather than exclusive members, reinforcing the Knox vision and core values at every opportunity.

Websites are always works in progress needing constant care and attention. We gain insight into important informational resources and trends by analyzing people behaviours on the website – where do they go, how long do they stay and do they go somewhere else after the Knox site.

In the last year 10,720 different people visited the Knox website. That is a 71% increase in traffic over last year. We intentionally targeted outside the Knox building over the past 12 months and were rewarded with 25,971 unique minutes of attention from visitors coming from over 100 cities – although most still come from the Greater Vancouver area. We have **1071 regulars** who re-visit the site **every single month** and an additional 823 who have come back for at least 3 months in a row.

Our mobile users have increased 94%. We get the most referrals from Google quick box at 66%, with an impressive 26% of organic users going to our anchor pages directly. Social referrals like Facebook have fallen over past years (the exception being 234 referrals from Rev Richard's personal account). We maintain around 4289 unique pages with large, eye-popping images, music and videos loved by our users.

Some of you may have noticed that the website underwent a platform upgrade just before Christmas this year (I still can't believe the timing of that). With the skills and dedication of ASEND (formerly ChurchOS) we will continue to implement improvements as the technology evolves.

Here are a few highlights of what captured the attention of the Knox Web Community:

- Predictably, the most accessed icons on the Knox site are location, time of service, directions, and the calendar.
- The HOMEPAGE still has the most visits, followed by EVENTS, ABOUT US, NEWS, and SERMONS.
- The LONELINESS section has moved up in a very significant way during the 5 months it has been on the website presently tracking as the 7th most visited ministry.
- PRAYERS have more visitors than ever before, currently holding the number 3 spot.
- WEDDINGS show the biggest increase with 86% more visitors. The wedding 'guests' also stay on the website 4 times longer than most other visitors.

- Although underutilized at present, the website is also a DONATION pipeline.
- The most visitors in a single day occurred last March 2018 when 789 visitors went to the EASTER & LENT posts.
- The Office of the Moderator of the United Church of Canada visited the Knox website 176 times over the last 12 months.

Exploring Faith Team

Exploring Faith Team started 2018 with a well-attended and stimulating study of the book *The Heart of Christianity*, a 12-week series continued from the previous fall.

The Lenten study, on the book Why I Believe, was similarly attended, and well-received.

Instead of a large group study in the fall, we chose to do two smaller groups to build an opportunity for closer community and more intentionality in our faith walks. We used *A Spiritual Formation Workbook* to guide and inform us of the various traditions of Christian faith practice.

During the spring the Team started research on Loneliness, to get some grounding on the issue for our congregational efforts to address our vision to build a community without loneliness, and in preparation for hosting a Forum on loneliness in the fall. The team continues to be active within the ad hoc Loneliness group as our congregation moves forward on this issue.

During the summer each committee/team was asked to refine its goals and mission. At this time we tightened our focus to emphasize and affirm our goal is to become more like Christ, and therefore to become anchored in Scripture and Jesus. Work we may do about other faith groups is primarily to become better neighbours rather than to explore other faiths. This refinement in focus led to the decision recently to change the name of the group to Faith Formation.

We welcomed Rev Richard Chung in 2018, first as temporary minister and then joyfully as our called minister. We thank Rev Richard for his active role in our team's leadership.

Thanks to the team, for all your hard work, and love.

Worship Committee

Over the year the worship staff members, Colleen, Madelene and Anne have met regularly with Richard as the Worship Craft Team. This group does just as their name implies, they "craft" the worship services by planning music, stories, readings, prayers and children's time to support the themes and lectionary of the particular church season. We are most grateful for all the amazing work done by this team. With an understanding of the goals of the Worship Craft Team and of the season's themes, one of the roles of the Worship Team is to be alert to the experience of worship from a personal level and to listen to input from congregational members. We then review and evaluate the services at our meetings always keeping in mind our Vision and Mission and our team's 3-year objectives. As a team we support worship by preparing the communion elements and recruiting servers each month, finding weekly scripture readers, ushering and finding others to help with candle lighting, offering and so on. We also choose and order bulletin covers for all services. During 2018 we arranged pulpit supply for 3 services, planned lay led services for 2 Sundays, hosted 3 SummerSpirit services plus the Christmas Day SummerSpirit service. Thanks to Madelene and Colleen who arranged for, and practiced with, vocal or instrumental soloists or groups for 28 of our services!!

A few highlights of 2018 were: Richard's covenanting service; the All Saints service with many families in attendance; our beautiful Christmas sanctuary decorations; the Advent candle lighting based on the anthem *Love's Pure Light*; experimenting with various music genres during Lent; our 'tree with its long roots' crafted by Colleen; very meaningful Remembrance and Reign of Christ services; the Advent Peace Box with its weekly reflections on the meaning of Hope, Peace, Joy and Love for the Holy Land; the Christmas Sing-Along with refreshments; the outpouring of food gifts for 1st from our Thanksgiving service and from our Christmas can tree; Blessing of the Animals (Boots arrived after the dogs left!!) that for the first time also included a donation of towels to the SPCA; our Easter service with the fabulous trumpet music and, as always, the magical Christmas pageant written and directed by Anne.

Children & Youth

The Children & Youth at Knox range in age from approximately 3-18 years. While our regular Sunday attendance may be small, we have had an increase in the number of children attending the services, often through visiting families and grandchildren.

The children participate in Sunday services during our Time For All Ages. This year, we also looked at new ways to involve the children by having them teach the congregation sign language for the Call to Worship, and participating in the dramatization of scriptures. We will continue to explore these opportunities in the coming year.

Some of our older youth sing with the choir, play in the Bell Choir, and help out in services such as The Blessing Of The Animals, and our Christmas Eve Pageant. They also regularly volunteer their time to help out with the Thrift sale, Community Lunch and a variety of other events that are a part of the life and work of Knox.

In September, we started focusing on our neighbours around the world and learning how children live and worship in different countries. Out of this came our fundraising drive for UNICEF. Through donations the children collected from the congregation and through the sale of our Christmas Cookbook, we raised \$416.00. The children then chose the following gifts to purchase through UNICEF to help children in need:

The Children & Families Ministry at Knox continues to change and grow. Part of that includes connecting to our neighbours and opening up our doors. We have many children's groups that use the Knox facilities throughout the week such as Brownies, Cubs, The Preschool, Acting UP! and Little Kickers. For each of these groups, Knox provides a safe, nurturing place for these children to learn and grow. And through our new mission, we are excited to find new ways for Knox to connect with children and youth in the coming years.

Our Pastoral Care Committee

We usually meet with our minister, Rev. Richard Chung, monthly on the second Tuesday between September and June when we share our phone calls and visits and our concerns about our congregational members' needs. At each meeting we respond to his requests and together we update our prayer list. One of our members offers words of inspiration.

We have a "card ministry" where one of our members sends cards on happy occasions such as "special birthdays", births, marriages or graduation and get-well cards for illness or sympathy cards for bereavement. ***Please call the office if you know of someone who would appreciate receiving a card for a special occasion.

Our Pastoral Care Team is continuing to make a list of CONTACT PEOPLE for the congregation in case of a medical emergency on Knox property. ***Please call Joyce Kruger if you wish your contact information to be on the list.

Our "Information Package regarding Memorial Services" is still being used when needed by our church members. Our Pastoral Care Team Liaison offers support to those people in that situation by phoning the bereaved family member, meeting the caterer and attending the service and the reception.

Three members of our Pastoral Care Team, Rev. Sharon Copeman, Sydney MacKenna and Joyce Kruger are still involved with the "Seniors' Working Group "(SWG) of the Westside Churches planning committee. There were no special events scheduled this year by the SWG. Members of the SWG have developed a resource "A GUIDE TO SENIORS' RESIDENTIAL CARE FACILITIES IN GREATER VANCOUVER" for use by members of pastoral care teams, ministry persons and congregation members in all the west side UC congregations. Copies of this resource are available in our Fellowship Centre entrance.

We also have a "Prayer Shawl Ministry". There are seven people willing to knit prayer shawls for those who may appreciate receiving one.

On behalf of the Worship Team, we contacted relatives and/or friends of members who have passed away during the preceding year. They are invited to light a candle in memory of their loved one at our annual "All Saints' Day Service". It is a very meaningful service.

We have enjoyed working with Rev. Richard Chung this year.

Stewardship and Social Justice Team

In 2018 the members of the Stewardship and Social Justice Team gathered for meetings in June 8, October 4 & 29, and December 13.

Our relationship with the AlZaza family continues to provide focus for some of our members and brings opportunities for learning and growth. In April we hosted a baby shower to celebrate the birth of Lana. In December some of us attended *Can the Displaced Speak? Refugee Muslim Young Women Negotiating Identity and Belonging Through the Camera Lens*, a display produced under the guidance of a UBC PhD. candidate in which Sana was a participant. We are planning to bring this display to Knox this spring as we focus on isolation and loneliness, certainly one of the potential issues for refugee families.

We continue to draw attention to the desperate situation of Palestinians in Israel through focus minutes in announcement time and sharing and forwarding information received. In July we had a guest speaker in worship who spoke of her experience as a Jewish woman living and working for a just peace in Israel/Palestine, who has moved to Vancouver, when we hosted a freestanding exhibition titled **Promised Land - The Jewish Museum of the Palestinian Experience** which traces the history of the relationship of Jews and Palestinians in the Israel/Palestine conflict. The panels are currently stored at Knox and available to others who may want to show them. In December we once again focused on the UCC Unsettling Goods Campaign, and the International No Way to Treat a Child campaign.

In affirming our call to be good stewards of our earth we will strive to minimize the use of single-use plastics in our congregation, families and neighborhood. Frances Herzer is helping us to work with this new focus.

Some of our members have attended the forums addressing our Knox vision and mission to work to address and alleviate issues of isolation and loneliness in our community and beyond. We are exploring ways that our work aligns with with mission, and new initiatives we feel called to pursue, with Richard's guidance. We are involved in the exploration of how community lunches may evolve and note that sandwich-making for First UC has been discontinued.

Preparation of the 2019 Stewardship Campaign materials was accomplished with greater ease this year, benefitting from the learning and design skills developed last year. Response was strong and achieved in a timely fashion. Thank you!

Groups under our umbrella include:

<u>Community Lunch</u> - \$425 per month for 10 months, totalling \$4250 per year. This sum includes fees for two workers from First United at \$60 each. Funding also comes from Vancouver Foundation at circa \$2000 yearly. This team has expressed their tiredness, and declared they will continue only till the end of June, 2019. We are meeting monthly with those directly involved to discern the future of this endeavor.

Sandwich making - 6 times a year at \$40 each. This program was discontinued by First UC.

<u>Coffee Fellowship</u> following worship is usually covered by members' donations.

S&SJ Team members are John Carr, Adrienne Burton, Richard Dunsterville, Frances and Bill Herzer, Betsy Morrow and Sharon Copeman. We appreciate the assistance we receive from Dave Cass, particularly in our work regarding Israel / Palestine.

Healing Touch

Our group has been very busy this year. The list of people who sign up after Community Lunch shows that interest in achieving a peaceful, restful state is high on people's minds. "Word of mouth" has been our best advertisement as shown by the diversity of people who come and go as well as the regulars. At the Tuesday group there are typically less after holiday breaks but soon it gets busy as well.

We are fortunate to get assistance from other churches which covers our need with growing number of people being treated. As well the loyal group of fellow practitioners help make this ministry possible. With neighboring Churches holding Healing Pathway courses we have attracted a couple more practitioners who have made Knox their primary place of giving treatments.

Healing Touch uses hands-on techniques that work to restore wholeness of body, mind and spirit by promoting flow of the energy field that surrounds the body. With stresses in life we sometimes block this flow unintentionally. The process attempts to balance this flow which then balances the physical body. Restoring wholeness in this manner opens up and taps an inner reservoir of peace, insight and strength that is available to all. F&PM - Facilities and Property Maintenance Committee

This committee is responsible for the maintenance of the Knox property. <u>A caution to the congregation</u>: The longer the delay in construction of the new church hall, the increasing risk of possibly expensive maintenance of our rented Fellowship Centre. (roofs, furnaces, plumbing, etc.)

Members are: Ed Williams, Richard Dunsterville, Don Bliss, Larry Tench, Wendy Trant, and Berkeley Scott. We have been not been successful in finding a chair-person for the team, so have only held two meetings this year and this has helped us in identifying needed work and possible future work.

Completed Projects in 2018:

- The existing church security system was tested, and the 10 smoke detectors were changed from disarmed when church was occupied, to armed at all times. That made sense. A detailed write-up is being created to help others will understand the system. A new keypad was installed by the chapel door, necessary when construction prevents normal North-East entry.
- Spring/Fall Gumboot Party: Unfortunately, without someone organizing these clean-up parties, nothing was held this year. Some work on the outside was accomplished, by a few people to endure the hedges were cut, the gardens weeded, and the front lawn flattened, and many grass divots replaced. Nothing was specifically organized for inside cleaning, but M&P has hired Cheryl Freedman, to add about 4 hours weekly to special cleaning
- The Memorial garden gets special maintenance, supervised by Joanne Melville. Our sincere thanks to her!
- Richard Dunsterville pruned many overgrown branches from the various trees and brushes on the property.
- Although the boiler is only 2 years old, we decided to have an inspection in 2017, but had too many problems arranging for a company. So, in 2018 we hired Gandy Installations to service it and the gym rooftop furnace. Both required ignition work.
- The front and back steps and side rails were repainted.
- Wi-Fi: Telus installed a new router in the sanctuary and another in the lounge. Thanks to Ed Williams for arranging this.
- To meet current regulations for our buildings we are investigating the need for lighted exit signs and panic hardware for the main entrances to the church. (these will allow these doors to be locked but still provide emergency exiting). F&PM will follow-up on purchasing fin seals or other type weather-stripping to minimize air loss through the inner doors when outer doors are open.
- We had Nechako Lawn Services come two times to fertilize and put nematodes on our front and back lawn. On the front lawn it did not seem to work, because the crows have pulled numerous divots and the lawn now needs some remediation. Maybe we can get volunteers to form a team to do this.
- Richard Dunsterville and Larry Tench re-furbished the Chapel exterior door which is now like new. They also replaced the white tarp we had on the main lounge roof since the January wind storm tore up the previous tarp.
- Larry Tench installed temporary handrails on both sides of the chancel front to help some members into the choir seats. These are presently being replaced by a professional woodworker.

2019 Projects for Consideration / carry-over from 2018

- A lawn irrigation system would improve the facility grass and gardens and would also require much less staff time. This should be coordinated with the new building plans for its new gardens.
- The church dimmer system is still half operative. Repair or replace?
- Overall review of the yard plantings to make the exterior gardens more appealing and appropriate for the church setting.
- The Chapel's three windows are still awaiting protective plexiglass covers to be installed.
- The protective plastic on the east church windows were also removed to allow painting but have not been re-installed. The middle window plastic could be re-installed since it is in good condition. The plastic over the other three large windows are all cloudy in appearance and will not be re-installed. The question is should we replace these cloudy panels with new, clear plastic? There are leaded glass repairs to be done also.
- The old main notice board on Balaclava St should be replaced and illuminated.
- The risers of the front steps need renovation (not just painting).
- The chapel and the choir rooms are cold, and need added electrical heaters when electrical system capacity is increased. As a step in improving this situation, the team voted to have the chapel exterior walls insulated by an outside contractor. This in 2019's budget.
- The Knox Church community would like to see a more inviting presentation of both the exterior and interior of both buildings. Changes or additions will need to be identified that will reach this objective.

Once again, I am especially thankful to Paul O'Neil who is always committed to doing that extra effort for the benefit of the church and those whom he works with. Thank you Paul!!

ENVELOPE REPORT

There are 43 contributors who pledge to the local church, 25 of these also give to Mission and Service. We have 57 contributors who do not pledge but give to the local church and/or Mission and Service. There are 15 People who have chosen to use the Pre-Authorized Remittance System (PAR).

Welcoming and Communications Team

This year the Knox Welcoming and Communications Team continued its practice of conducting our formal meetings via teleconference, with members dialing into a shared phone line and looking at slides shared on the computer screen. We found this continued to be a useful method to find mutually convenient times to meet, and to facilitate brainstorming and reaching consensus on goals and activities. The team continued to coordinate outside formal meetings via email.

Based on the early direction from the working vision statement from the 2018 Knox Leadership Retreat, the team met in April and May 2018 to lay out a roadmap of priorities and goals over the next 3 years that aligned with this statement. Asking "which team objectives would help contribute in advancing our vision" we found a familiar theme at the top of our near-term priority list: that of maintaining and growing a strong greeting/engagement/follow-up process. Looking further, themes of supporting more events and gatherings, improving signage, and growing media coverage came into view.

The team activities roadmap we laid out were as follows, some of these have been accomplished and others remain works in progress:

2018-2019

- By end of 2018 have an established Greeter-Engage-Follow Up "process" that is working
- Brainstorming/workshops on welcoming/follow up–what works in other places? What are we doing today that makes people feel welcome?
- By end of 2018 have all willing congregant photos up on our wall/formalize.
- Have the greeter Team and all Knox attendees know and use the methods we will have in place to encourage continuing attendance by all Guests—both Knox "regulars" and visitors. (Continuing into 2019-2010)
- Institutionalize pot-lucks every couple of months. (Continuing into 2019-2010)

2019-2020

- Have more signage in place outside and inside the church and fellowship center
- Country-themed gatherings where we share food from the country and people who have been there share their stories.
- Possible events: Hear a story/tell a story, to help people form connections. Everyone shares.

2020-2021

- Having Knox be a welcoming center for the community
- Have 1-2 annual arts events in our space that are anchors in the community
 - W/C goal: Media coverage of these to increase our reach so we connect with the lonely
 - o Tie in a launch event to our new fellowship center

Our progress against these goals has been intermittent, strengthened by the leadership that Sandra Adams demonstrated in coordinating our dedicated cadre of volunteer greeters, particularly around Summer Spirit and over the Advent and Christmas season.

The Team's advertising campaigns were once again primarily focused on the prominent services around Easter, Advent and Christmas. Online promotion continued (with the help of Debra Danny) and in local community magazines in Dunbar and Kerrisdale, as well as the BC Conference (now Mountain) events calendars. As previously noted, it is a challenge to measure the effectiveness of print advertising, which was our largest line item expense.

The Team continues to value and appreciate the tremendous support it has received this year from Debra, our many greeters, and the other teams who have worked with us. We remain energized by the new visioning direction, the pending construction of the new building and the opportunities this will afford to engage all our guests, both inside and outside the walls of Knox.

Treasurer's Report

It has been an eventful year, especially with the expected building of the new fellowship center, everyone was hopeful the ground would be broken in 2018. Unfortunately city hall has slowed their permitting so the wait is still with us. Our new minister and board have started to diligently promote a new vision for Knox. As treasurer I work with both the board and finance teams to monitor and report on our operations and special funds financial status is known and understood. This year as with 2017, our pledges, offerings, special appeals and events income, and rental income did not keep up with the expenses incurred with personnel, maintenance and other team service costs, but this was the first full year we have invested the money we received for the sale of the property to Hon Towers. The trustees invested this money and over the year received a monthly income, which we never had before. This income was sufficient to cover our deficit with a small amount of a surplus for our operations in future years.

Our new minister which you will read about in his report has been very busy both with providing his ministerial services but also with meeting teams, board, trustees and staff. These were successful in understanding the overall congregational sentiment for doing more with our community than we have in the past. There are also big changes in the United Church going to a three council organization from a four council. This means the Presbytery being replaced and there will be two regional council in B.C. Initially the UCC assessments will be higher for the next 3 years (10%), and in the meantime the UCC will have time to evaluate how the full church operations can best be funded. One aspect which has been changed for the better, is that money that is donated to Missions and Services will only have a small organisation costs and most of the money will go directly to the various charities supported.

I am pleased to report that in 2018, the Congregation fully supported the church by increasing pledges and offerings, and along with much increased rental and other income, we were able to come about \$40,000 under our projected deficit. The participants in the Stewardship Campaign and other appeals should be thanked for their efforts, as well as, all other teams for carefully conserving their spending where they could.

In the table I have included the last 5 years' actual numbers and 2019 Projected budget numbers (be aware that we normally have better actual results than budgets). Also, the extra projected costs in 2019 have primarily been due to the new vision that has been adopted by the board. Included in this new vision is to upgrade the sanctuary's sound system and add two large monitors to improve the services so that all hymn

wording will be visible without requiring the hymn books, plus allowing other prospective rental venues an improved space. Facilities expenses will increase since we have purchased an AED (defibrillator), which will be located in the hallway in the fellowship centre and secondly we budgeted for adding insulation to the chapel walls to improve the heating and warmth. The land sales money has been invested and base on our full 2018 year we received about \$140,000, thus covering the larger than normal deficit.

This report also accompanies the 2018 Year End Operating Statement and the 2018 Year End Special Purpose Fund Statement.

With enthusiasm and commitment by us, the congregation, good investments by the Trustees and team help, we will prevail and hopefully thrive.

VANCOUVER SOUTH PRESBYTERY

This will be the final Presbytery report to Knox as Presbytery will soon be no more. I attended the last few



meetings of that body for our congregation. The change in structure has not yet been completed as the United Church of Canada was brought into being in 1925 by an act of Parliament and until the current parliament brings forth the legislation to change our structure it cannot be completed. The disposition of monies from the Vancouver South budget was clearly an important issue. It was

agreed that a surplus of about \$15,000. would be moved to the upcoming Region 1 and be designated to be spent on the advocacy program run by Wilson Heights United. Similarly, the projected surplus from the Operating budget (~ \$52,000.) will be designated to support the ongoing work of the Youth and Young Adult Ministry. There is an agreement that Region 1 would honour designations of this sort during the 1 to 2year period of transition.

Much discussion occurred regarding the size of the regions in the west. It was proposed that the western area be represented by two regions in a north-south division. However, Presbyters in British Columbia were quite against this proposal and the entire province was finally designated as Region 1 which was subsequently named the Pacific Mountain Region.

There was a very lovely farewell dinner at Pacific Spirit United in which many stories were swapped and much laughter was heard throughout the room. There were a number of activities to help members release their anxieties and enable them to embrace new ways of working.

It was evident that the Presbyters were both quite sad at the ending of Presbytery but also excited about the possibilities that the new structure will bring. There will obviously be adjustments for all the congregations in the region but already some churches have re-organized their approaches to worship and to community engagement. A significant challenge will be how to set up communication lines in such a large region and the difficulties of accommodating the differences in the character of the various parts of the province. However, we must rely on the leadership of the Spirit as we all move forward to do God's work.

Financial Team Report

The Finance Team this year consisted of Chris Lay, Doug Graham and Bruce Herzer, Larry Tench and Margaret Pendray. In addition, Josie Barley and Robyn Brassell continue to work with Larry to ensure the accounts are accurate and assist Knox in knowing where the money comes from and goes. Thank you everyone for all that you have done over the past year.

We should celebrate the BIG MILESTONE Knox reached this year. Knox for the first time received 12 months of investment income from the \$4M Capital Fund resulting from the Property Sale to Hon Towers. This income has allowed us to cover the deficit for the first time this year. We are grateful to the Board of Trustees Investment Team, under the Chair of Chris Lay, for managing the capital fund.

The Board supported a Review Engagement again this year especially as we are still awaiting the beginning of construction of our new Building and the expenditure of considerable funds. We are pleased to advise you that our Accounts now meet the most recent Canadian Accounting standards. Manning Elliott (ME) have proven to be good Company to work with and have provided their services at a very reasonable cost.

In the fall we again reviewed the Budget Process with the Board. The ACM timing is dependent on Knox receiving the Review Engagement Report for 2018 by the end of February, which means that Knox needs to complete all its 2018 accounts by the second to third week in January so that ME can meet their deadline. This was done.

In June the Board, Board of Trustees, Building Committee and the Finance Team all met to improve integration, and collaboration. It allowed for discussion, clarification and some concepts in future finance planning. In addition, we decided that all Board of Trustees Trust Accounts and Special Purpose Accounts must have clear *Terms of Reference* stating:

the name of the account, purpose, date initiated, and amount of Funds deposited. This will provide clarity for those doing the accounting and ensure that we are handling the donation accounts responsibly.

Quickbooks, the accounting software used by Robyn Brassell, our accountant, was placed in the cloud this year. It is a major contribution to the *Risk Management* of Knox's Finances. It allows anyone with experience in the use of this software to be able to access the Knox Accounts whenever Knox requires them.

Two members of the Finance Team, Larry and Bruce, provided financial and presentation skills for the Stewardship Campaign this year. This Campaign was ably led by Sharon Copeman. Thanks to all of you.

While Knox has income from the \$4m Capital Trust Fund we still need to be vigilant in spending money as we have a limited amount of reserve funds available for any future expenses. The funds realized from the Capital Fund are dependent on the money markets. In addition, there is always the risk that Building Projects may go over budget and these may not be small expenditures. As a result, while our financial position is much healthier than it once was, we still need to be creative in looking at ways to manage our funds and to determine how to raise more money. Our goal is to help Knox be able to maximize its financial resources and serve our Vision as we are called to do.

Knox Building Committee

2018 was an eventful and hopeful year for the Building Committee and the advancement of our building project. However, with the arrival of a new City Council and a somewhat unpredictable situation at City Hall, we have met with continuing delays impacting an anticipated start to construction. This report will provide you with an up to date reality check and an explanation of the delays.



We can advise that as of the date of this report all necessary documents required for the approval of a Building Permit for the new Knox Fellowship Center are now in the hands of City Hall. This is thanks to the ongoing planning and preparation by the Architects, RHA, the support of the Contractor, Jakin Engineering & Construction Ltd, Hon Towers, the Developer and the expert advice of many consultants. John Scott, our contracted advisor, and the Chair of our Building Committee have attended bi-monthly meetings with all concerned during 2018 to ensure that the interests of Knox have been well represented.

Delays:

The delays at City Hall have resulted from the need to comply with several bylaws and the related permitting procedures they demand.

- * A critical permit is required to allow demolition of the existing houses on 41st Avenue.
- * Without demolition construction, equipment cannot access the Knox site. Delay for this permit involves the one remaining tenant in a house on the property. By law (and we support this law) he cannot be given a final eviction notice until all permitting has been approved. From this date he has four weeks to vacate the premises with adequate financial support to allow his move to a new location. This projects that the earliest time construction might begin would be late Summer or early Fall.
- * All parties involved in the Knox project requested a meeting with City Hall to explore any opportunities to reduce the time delay. We subsequently met with a City representative, expressed our disappointment at the delays, and at the same time suggested realistic options that respected the interest of the tenant and would allow earlier access for construction equipment. These options were passed on to senior City management for consideration but were later rejected. While all this took time, effort and additional cost for the architect and contractor, we were back to a possible late summer or early Fall construction start.

At the end of last year's report, we wrote the following:

Once the Building Permit is received, we can finally anticipate an early start to construction activity on our parking lot. The Building Committee will issue monthly news updates to the congregation to ensure that we are all aware of our progress.

We regret that the "early start" has been elusive but be assured we have made every effort to provide that long anticipated beginning. We all long to know the "when" but sometimes the bureaucracy we live by can be counter productive.

Please be assured that all we must do is in place and that the building <u>will happen</u> to support our very exciting Vision and Mission. That Vision and Mission are already a reality. Your patience and support along the way has been much appreciated. Now we need you there to cheer us on towards completion!

	Revenue: • Revenue for pledges and offerings is about the same between 2017 actuals and 2018 proposed budget.
	 Other revenue – will be unusual due to the sale and construction so we assume this and pext year will may have reductions in rental. This year the preschool

hasn't been operating since the beginning of the year because they require parent participation and most parents are now both working. They are reorganizing themselves. We expect income from the until June. Total use of rentals now \$18,800 instead of around \$35,000 last year.

- Special Events revenue We are assuming Thrift Sale won't be as high as last year's unusually high income. We can't predict movies and other one-time events.
- Note that we will be setting up a Rentals Team this year, for this building as well as for new one, once we have it.

Expenses:

- Every year until now we've paid for our costs by ourselves. The last 4 years have been difficult, but we have been using the developer interests payments to offset the deficit. This year we are anticipating investment income of \$110,000.
- Expenses Personnel and Search Team costs have gone up due to change in minister; we have a contingency for this. Also, we are now including our accountant in Personnel rather than as a consultant.
- Facilities & Property Management costs are budgeted at around the same, but we
 may have some costs coming.
- o Finance Review Engagement cost this year and will also cost next year.
- o Our Operating Deficit is larger than it looks, because investment income.

MOTION: Doug Graham moves and Richard Earthy seconds that the congregation approve proposed 2018 budget.

Questions & Discussion:

- John Carr personnel cost breakdown available? Other churches do this. We haven't in the past. Rev. Richard Chung says it should be public. Verify from BC Conference. Susan McAlpine will add this to next Board agenda and will report back to the congregation.
- Bill Goodsir What committee has responsibility for looking ahead to markets to give us a contingency? Larry Tench – Finance. Until we know what plans we have it will be hard to know what it will cost us. We have a 3 – 5 yr plan, this is what VSP will be interested in. Susan McAlpine - Many of the questions will addressed later in the meeting as we talk about Board report. Alan McKenna – the purpose of the sale was to get investment capital; Sharon Copeman – At the VSP presentation last fall we referred to visioning for mission, which will also be paid for from investments. Chris Lay – The figure presumes no increase in capital gains, whereas it is likely we would have capital gains which would increase our investment capital for the Trustees.
- Thanks to Larry Tench for all your work in learning the Treasurer position and doing it well.
